**OPINION OF PROBABLE CONSTRUCTION COST: \$1,298,100**

The scope of work consists of point repairs to sanitary sewers, installation of cured-in-place-pipe, lining/repair/installation of manholes, and other sewer work necessary for these items.

The bid specifications, drawings, plan holders list, addenda, and other bid information may be obtained from the Public Works Department. Only electronic versions of the bidding documents will be available. Electronic bidding documents will be provided to the plan holder at no charge. All prime contractors bidding the project must obtain their plans and bidding documents directly from, and be plan holders with the Public Works Department. Bids must be in accordance with the specifications and on the forms available from the Public Works Department and must be submitted in a sealed envelope marked **ELLA ST, S SANDUSKY ST, AND S RIVER RD SEWER REHAB PROJECT – OPWC CP38AB**. **An optional pre-bid meeting is set for June 11, 2024 at City Hall, 51 East Market Street at 1:30 pm. No additional pre-bid questions will be accepted after completion of this meeting.**

Each bidder is required to furnish with its proposal a Bid Guaranty and Contract Bond in accordance with Section 153.54 of the Ohio Revised Code. Bid security furnished in Bond form, shall be issued by a Surety Company or Corporation licensed in the State of Ohio to provide said surety. Each proposal must contain the full name of the party or parties submitting the proposal and all persons interested therein. Each bidder must submit evidence of its experiences on projects of similar size and complexity. **The owner intends and requires that this project be completed no later than June 27, 2025.** All contractors and subcontractors involved with the project will to the extent practicable use Ohio products, materials, services, and labor in the implementation of their project. Additionally, contractor compliance with the equal employment opportunity requirements of Ohio Administrative Code Chapter 123 is required. Bidders must comply with the prevailing wage rates on Public Improvements in Seneca County and the City of Tiffin, Ohio as determined by the Ohio Department of Commerce, Bureau of Wage and Hour Administration, 614.644.2239.
